Constitution of ATU Pool Club

Name

The club shall be called ATU Pool Club.

Aims and Objectives

- To promote the sport of 8-ball pool using the international ruleset.
- To provide coaching, recreational, and competitive playing opportunities for members.
- To foster a friendly, inclusive, and safe environment for all members.
- To encourage sportsmanship and respect among players.
- To organize club events, competitions, and social activities related to pool.
- To manage pool facilities and equipment responsibly.
- To actively engage with other Irish college pool teams in events such as:
 - SSI League (Semester 1)
 - SSI Cup (Semester 2)
 - Intervarsities (Semester 2)
- To participate in friendly matches with other local colleges as part of the club's competitive and social activities.

Membership

- Membership is open to students and affiliates of ATU Galway who participate in club activities.
- There is no annual membership fee.
- Members are responsible for contributing their share of training and travel costs as needed.

- For example, if the club rents tables at a local pool hall for training, members pay the cost per person as requested by the venue.
- The club committee will collect these funds from members and pay the establishment directly.
- Membership requires agreement to these cost contributions and adherence to club rules and constitution.
- The club is managed by an elected Committee consisting of the following titles:
 - President
 - Vice President
 - Secretary
 - Treasurer
 - o Public Relations Officer
 - Welfare Officer
 - Equipment Officer
 - Up to two Ordinary Committee Members
- Committee members are elected annually at the Annual General Meeting (AGM).

Governance

- The Committee is responsible for the day-to-day running of the club, financial management, organizing events, and enforcing the club constitution and rules.
- The Committee meets at least quarterly and as required.

Meetings

- An AGM shall be held annually for the election of committee members and discussion of club business.
- Extraordinary General Meetings (EGMs) may be called by the Committee or by at least 10% of members.
- Quorum for all meetings shall be 25% of the membership.

Finances

• Club funds come from member contributions for training and travel costs, fundraising, and sponsorship.

• The Treasurer shall maintain accurate accounts and provide an annual financial report at the AGM.

• All club funds shall be used solely to support the club's aims and activities.

Discipline

 Members must behave respectfully and in accordance with club values and policies.

• The Committee may suspend or expel members for misconduct following a fair and transparent process.

Amendments

 Amendments to this constitution require a two-thirds majority vote at an AGM or EGM.

Dissolution

• Upon dissolution, any remaining club funds or assets shall be donated to a local charitable organization as agreed by the Committee.
